



- 1. McMahan/Wrinkle Airpark Development Board** **3 year term**  
Council appoints seven (7) community members at large to provide guidance in regard to matters relating to the Airpark.
- 2. Board of Adjustments & Appeals** **3 year term**  
Council appoints 1 Engineer/Architect, 1 Master Plumber, 1 Mechanical Contractor, 1 Master Electrician, 3 community members at large, and 2 ex-officio members that represent Atmos Energy and Oncor Electric to provide guidance and boundaries in regard to rules and regulations within the construction and housing rules of Big Spring.
- 3. Civil Service Commission** **3 year term**  
City Manager appoints three (3) community members at large to provide assistance & support for civil service employees.
- 4. Convention & Visitors Bureau Board** **3 year term**  
Three (3) City Council members that are appointed by majority vote of Council and serve during their time of office and can be reappointed following consecutive reelections, City Manager, Finance Director, and the President Elect of the Big Spring Chamber of Commerce Board of Directors that is serving their term in office, and one (1) community member at large that assists in the promotion of tourism and visitation of the City of Big Spring.
- 5. Planning & Zoning Commission** **3 year term**  
Council appoints seven (7) community members at large to provide guidance in the matters relating to projects regarding planning and zoning within the City of Big Spring.
- 6. Zoning Board of Adjustments** **3 year term**  
Council appoints seven (7) community members at large to provide guidance in regard to matters relating to the allowance of adaptation of existing City of Big Spring zoning ordinances.
- 7. Historic Preservation Commission** **2 year term**  
Council appoints one (1) Main Street, Inc. representative, one (1) architect/planner/design representative, one (1) historian, one (1) licensed real estate broker, one (1) attorney, one (1) owner of a landmark or property within a historic district, one (1) archeologist or related discipline to assist in the preservation and promotion of economic vitality and restoration of the historic area.
- 8. CRMWD Board of Directors** **2 year term**  
Council appoints four (4) community members at large to provide guidance and assistance regarding water acquisition.
- 9. Big Spring Economic Development Committee for Big Spring, Inc.** **3 year term**  
Council appoints five (5) community members at large to provide guidance and assistance regarding economic development for the City of Big Spring.



- 10. Howard County 911 Board** **2 year term**  
Council appoints two (2) community members at large, Howard County Commissioners appoint two (2) community members at large, and Volunteer Fire Fighter Assoc. appoints one (1) representative to assist in the guidance and matters involving the 911 response within the County and City.
- 11. Teen Court Board** **Indefinite Term**  
Big Spring ISD appoints one (1) member, Howard College appoints one (1) member, Howard County appoints one (1) member, City Council appoints three (3) members, and one (1) Municipal Court Judge provide guidance in the regulation and implementation of rules and consequences regarding juveniles that have received discipline for their actions within the City and County.
- 12. Big Spring Housing Authority** **2 year term**  
Council appoints five (5) members to the board with at least one (1) member required to be a current or previous recipient of funding through this program. This program is managed to meet the requirements set under the State of Texas Housing Choice Voucher Program or SEVRA (Section 8 Voucher Reform Act).
